Other Changes or things to be aware of:

"Patient's Home Address" is required by the State. Feel free to use the buttons near the pt address info to make it easier - "Same as Incident Address" and "Homeless".

Also, you can just enter in the pt's zip code and hit the "Patient Address Postal Code Lookup" button. If you feel it isn't appropriate for some reason to get the street address, you can enter "N/A".

"Transfer of EMS Patient Care Date/Time" is required for transfers to a transporting agency OR to the hospital ED.

"Transport Agency" will almost always be Gold Cross, even for PMA Transports. We are not a "transport agency".

If a Vital Sign hasn't been completed, "Stroke Scales" will show up red. It does this because it is technically part of Vital Signs. But once your VS info is entered, this field will no longer be red.

If you see something required and you're not sure why, it's because it's a state or national requirement.
